- entire 2013 negotiations
- December 2013 the land was purchased
- July 2014 test production was launched
- September 2014 50 % of production was launched
- Employs 300 workers



Press Glass

- February 2014 the company is registered
- April, 2014 the land was bought
- July Creating a project
- Issuance of building permits in 1 day
- October 2014 First employments
- End of 2014 Realization of building a new gas pipeline within 10 days
- May 2015 start of test production


